Kosten	There is an administration fee. The amount of the fee depends on the type and scope of your application.
Verfahrensablauf	• You submit your application in writing or online and provide the necessary documents. • If you submit the application in writing, submit it by post or in person to the responsible office. • The responsible authority will check your application for completeness and correctness and, if necessary, request any missing documents or information from you. • The responsible authority will inform you in writing about the decision on your application.

Frist	The daily hunting license is valid for 14 consecutive days.
