Erforderliche Unterlagen	• if applicable: current photograph • Proof of statutory hunting liability insurance • written consent of your legal guardian or guardians
Voraussetzungen	• You are at least 16 years old and not yet 18 years old at the time of issue • You are a foreign citizen and do not have your main residence in Germany • You have the necessary personal reliability • You have the necessary physical fitness • You have taken out hunting liability insurance • The foreign youth hunting license you have already been issued with has been withdrawn • The blocking period set by the competent authority has expired • Consent of the legal guardian
Kosten	There is an administration fee. The amount of the fee depends on the type and scope of your application.
Verfahrensablauf	• You submit your application in writing or online and provide the necessary documents. • If you submit the application in writing, submit it by post or in person to the responsible authority. • The responsible authority will check your application for completeness and correctness and, if necessary, request any missing documents or information from you. • The responsible authority will inform you in writing about the decision on your application.
Bearbeitungsdauer	Up to several months
Frist	The annual hunting license for young people is valid for a maximum of two consecutive hunting years. The hunting year begins on April 1st and ends on March 31st of each calendar year.

Hinweise	With a foreign youth hunting license you are not allowed to take part in group hunts.
