Erforderliche Unterlagen	• Proof of suitable vocational training or comparable professional qualification • Certificate from a doctor who is authorized to use the field title "occupational medicine" or the additional title "company medicine" • Proof of specific expertise related to the activity (for example, through successful participation in a recognized specialist training course, proof of expertise in fumigation) • Official certificate of good conduct according to document type O
Voraussetzungen	• You are at least 18 years old • You have the necessary reliability to carry out the job safely • You have the necessary language skills to carry out the job safely
