Teaser	Do you have a residence permit for the purpose of education (study, vocational training or similar) and would like/need to continue your education beyond its validity period? Then you must have it extended in good time (at least one month) before it expires.
Volltext	You must extend your residence permit in time if you want to continue your education in Germany. This applies to all foreign nationals from non-EU and non-EEA countries who are completing training in Germany.
Erforderliche Unterlagen	<ul> <li>Recognized and valid identity document (e.g. passport or passport substitute)</li> <li>Current residence permit</li> </ul>

## **Sachverhalt**

- Current biometric passport photo (45 x 35 mm)
- Proof of health insurance coverage (for example: confirmation of health insurance coverage or insurance policy)
- Training or further education contract
- Approval from the Federal Employment Agency if this has already expired (usually obtained through the immigration authorities)

# With qualified vocational training:

- Proof of sufficient knowledge of the German language (for example: language certificate, German school, training or university certificates, proof of successful participation in the integration course, confirmation from the training company of sufficient language skills for the desired vocational training, confirmation of registration for a job-related German language course)
- Evidence of securing a livelihood (for example: proof of income, training or employment contract, pension certificate, proof of receipt of benefits such as parental or child benefit, maintenance payments)

# If you are a minor:

• Consent of the person with custody to the extended stay

If you are required to attend an integration course:

• Proof that an integration course has been completed or that integration into social life has taken place in another way. If an integration course has not yet been completed, the immigration authorities can refuse to extend the permit or only extend the residence permit for one year until the course has been successfully completed or proof has been provided that integration into social life has taken place in another way.

The documents and information must generally be presented in German. In individual cases, the immigration authorities may require less or more evidence.

Kosten	<ul> <li>Fee for extension EUR 93.00 (EUR 96.00 for less than three months) if an electronic residence permit is issued.</li> <li>If a sticker is used, the fee is reduced by EUR 44.00.</li> <li>If a fictitious certificate needs to be issued, this costs EUR 13.00.</li> </ul>
Verfahrensablauf	The application must be submitted to the immigration office responsible for you via the online residence permit service.  During the processing, questions may be asked and, if necessary, necessary documents may be submitted. The appointment and interview will take place on the appointment date.
Bearbeitungsdauer	Your application for extension of residence permit will be processed as soon as possible
Frist	The application should be submitted in good time so that the electronic residence permit can be issued before the current residence permit expires.
