Teaser	You can have your residence permit for the purpose of school-based vocational training extended before its expiry if you want to continue your school-based vocational training in Germany.
Volltext	The residence permit for the purpose of school-based vocational training is a temporary residence permit. You can apply for an extension of the residence permit if you want to continue your vocational training beyond the period of validity of your residence permit. Apply for an extension of your residence permit at least eight weeks before the expiry of the temporary permit at the immigration authority responsible for your place of residence. The same conditions apply to the extension of the residence permit for the purpose of school-based vocational training as for its issuance. In the event of an extension, your residence permit will

	<p>be limited again. The residence permit for the purpose of school-based vocational training will be extended for the duration of the training.</p> <p>As a rule, the residence permit cannot be extended if this was already excluded when the residence permit was issued or last extended.</p>

whether your immigration authority offers electronic application for a residence permit.

- If the application can only be submitted in person, arrange an appointment with the immigration authorities.
- During the appointment, your application will be accepted and your documents will be checked (please bring these with you to the appointment). Your fingerprints will be taken to issue the electronic residence permit (eAT).
- If you submit your application electronically, the immigration authorities will contact you after receiving your online application to arrange an appointment at the immigration authorities. During the appointment, your documents will be checked (please bring these with you to the appointment) and your fingerprints will be taken for the issuance of the eAT card.
- If your application is approved, the immigration authorities will arrange for the eAT card to be produced.
- After about six to eight weeks you can collect your eAT card from the immigration office.

**Bearbeitungsdauer**

The processing time usually takes 6 to 8 weeks and also depends on the completeness of the customer's documents. If documents are missing, the processing time will be extended. It takes about 4 to 6 weeks for the Federal Printing Office to produce the electronic residence permit.

- Extension of residence permit: at least eight weeks before the expiry of your current residence permit for the purpose of school-based vocational training

Rechtsbehelf	An objection against the rejection can be lodged with the department within one month after notification.
Kurztext	<ul style="list-style-type: none"> <li>• Residence permit for the purpose of training Extension for the purpose of school-based vocational training</li> <li>• Residence permits for the purpose of school-based vocational training can be extended if their period of validity expires in the near future and the school-based vocational training is to be continued.</li> <li>• The extension must be applied for at least eight weeks before the expiry of the fixed term.</li> <li>• An extension of the residence permit for the purpose of school-based vocational training is only possible if the conditions that existed when it was first issued are still met.</li> <li>• When the residence permit is extended, it is again limited in time.</li> <li>• An extension is not possible if this was already excluded by the immigration authorities at the time of issuing the visa or at the time of the last extension.</li> </ul>
