Verfahrensablauf	<ul> <li>You contact the advice center to describe your concerns and to arrange an initial appointment. This can be done by phone, email or in person.</li> <li>In the first conversation, you explain your situation and your concerns. This helps the consultants understand your needs and the specific conflicts or challenges.</li> <li>If necessary, further appointments will be made for detailed consultations. These discussions can take place alone, with your partner or with the whole family.</li> <li>During the consultation, the consultants analyze the situation together with you, identify problem areas and work out possible solutions. Both the legal and the emotional aspects are considered.</li> </ul>

	<ul> <li>The consultants will help you develop concrete agreements or arrangements to resolve conflicts or optimize the custody plan. This may also include creating written agreements.</li> <li>In some cases, follow-up support may be useful to ensure that the agreed solutions are implemented and to clarify any further questions or problems.</li> <li>The consultation ends when your concerns have been dealt with and you feel able to take the next steps independently. However, you can still request support if necessary.</li> </ul>
