Teaser	Operators who transport animal by-products must inform the competent authority before commencing their activities and will be registered there accordingly, unless it is part of the activities of an approved establishment.
Volltext	All companies wishing to transport animal by-products or their derivatives are subject to registration requirements in accordance with Regulation (EC) No. 1069/2009.
Erforderliche Unterlagen	Application Extract from the trade register
Voraussetzungen	You are an entrepreneur. Your business is located in the Hamburg area. They want to transport animal by-products. Further requirements vary depending on the type of activity and must be examined on a case-by-case basis.
Kosten	The approval is subject to a fee. The amount of the fee depends on the effort required for processing. The fees are determined according to the respective cost or fee regulations.
Verfahrensablauf	As an entrepreneur, you submit an application to the responsible authority, providing all the necessary information. These include, for example: Surname Address Information on which type of animal by-products are to be transported The responsible authority checks the submitted documents. Your company will receive a registration including a
