requires the submission of the same documents as for the initial issue:

- Recognized and valid identity document (for example: passport or passport substitute)
  - Current biometric passport photo (45 x 35 mm)
  - Proof of securing your livelihood (for example: from your own assets, payment of security into a blocked account, bank guarantee, declaration of commitment, scholarship, donations from third parties)
  - Proof of health insurance coverage (for example: confirmation of health insurance coverage or insurance policy).
  - Evidence of academic and language requirements.
  - For minors: consent of all persons with custody of the child to the planned stay (declaration of consent); if the parents with custody cannot submit the application jointly for their child, a written authorization from the absent parent is required; if custody is only granted to one parent, the signature of this parent is sufficient

The documents and information must generally be presented in German. In individual cases, the immigration authorities may require less or more evidence.

## Voraussetzungen

In principle, the same requirements must be met to extend the residence permit as when the residence permit was first issued. This means:

- You do not yet have a guaranteed place at university. You are also not planning to attend any preparatory measures for your studies (preparatory language course, preparatory college). The purpose of applying for a course also applies if you are initially entering the country to take part in an admission or selection process.
  - You either already have the academic and language skills required to study or you acquire them within the period of validity of your residence permit.
  - You can secure your livelihood and health insurance coverage for the duration of your stay from your own resources without having to rely on public benefits.
  - There is no interest in deporting you.

If you apply online, the immigration office will contact you after receiving your application to make an appointment.</li> <li>• If you are under 18 years of age, you must be accompanied by at least one legal representative (usually a parent) when you appear in person. If you have joint custody, the parents must appear together at the authority and submit the application on your behalf.
