Voraussetzungen	<p>Your company is based in Hamburg. If your company is not based in Hamburg:</p> <ul style="list-style-type: none"> • The federal state in which your company is based does not offer such notification. <p>If your company is based in another European country:</p> <ul style="list-style-type: none"> • You plan to work in Hamburg. <p>You meet the requirements</p> <ul style="list-style-type: none"> • to the investigation body and its organisation, • the reliability and expertise of the person in charge of the investigation body and • the number and expertise of the staff of the investigation centre
Kosten	<p>The fee for the approval of the testing center depends on the number of testing areas and is between 325.00 and 3000.00 euros.</p>

If necessary, the responsible authority will request further documents or information from you. • The responsible authority will decide on your application. • You will receive a notification from the responsible authority. • They are announced as water testing stations by the responsible body via the internet portal of the research system for measuring stations and experts

Bearbeitungsdauer	Processing usually takes 3 months after all required documents have been received.
Frist	You need to be registered as a water testing facility before you start your work.
