Teaser	If you want to extract groundwater, you must apply for a water permit. In some cases, this can only be granted in a formal administrative procedure.
Volltext	<p>If you want to extract groundwater in large quantities, you need a water law permit. You must apply for this. The responsible authority will examine your application and decide whether you will receive a permit.</p> <p>In certain circumstances, the responsible authority must carry out a formal administrative procedure. This gives those involved the opportunity to comment on the project. For this purpose, the authority makes the project public and, if necessary, holds an oral hearing.</p> <p>The permit specifies the type and extent of use for you and may be subject to conditions and ancillary provisions. In contrast to an approval, a permit can be revoked by the responsible authority. There is no legal right to use groundwater.</p>
Erforderliche Unterlagen	<p>Which documents you need for your application varies depending on the type and scope of your project. In a preliminary discussion with the responsible authority, you can clarify which documents are required in your case.</p> <p>Typically, this involves several or all of the following</p>

	<p>documents:</p> <ul style="list-style-type: none"> • Explanatory report • Site plan in which the existing or planned facility is marked in color • Information on the type of system • schematic representation of the system in plan and section
Voraussetzungen	<ul style="list-style-type: none"> • The groundwater and the public water supply are not endangered by your use. • Your project does not fall under public use, for which no water law permit is required.
Kosten	1,000.00 EUR - 12,500.00 EUR
Verfahrensablauf	<ul style="list-style-type: none"> • You send your application with the required documents to the responsible authority. <ul style="list-style-type: none"> • The competent authority <ul style="list-style-type: none"> • checks the completeness of your application and documents and contacts you if any information or documents are missing, • examines your application from a water management and water law perspective and, if necessary, involves other bodies. • The responsible authority shall make the project public. • If necessary, the competent authority will hold an oral hearing with the parties. • You receive <ul style="list-style-type: none"> • a permit or • a rejection notice • You will also receive a fee notice. • You pay the fee.
Bearbeitungsdauer	You must expect a processing time of 6 months. In individual cases, processing may take longer.
Frist	There is no legal deadline. Apply for permission well in advance of starting your project.
