Erforderliche Unterlagen	There is no uniform regulation in the federal states in which the water abstraction fee is levied.
Voraussetzungen	<ul style="list-style-type: none"> • They take water from a surface water body or drain water from a surface water body or • They extract groundwater or pump it, bring it to the surface or drain it away.
Kosten	The costs depend on the amount of water withdrawn.
Verfahrensablauf	There is no uniform procedure across the federal states, as this depends on the specific legal requirements and structures in each state.
Bearbeitungsdauer	The processing time depends on the quality and volume of the forms and documents submitted.
Frist	There is no uniform regulation in the federal states in which the water abstraction fee is levied.
