Teaser	If you want to use a road outside of a town not for traffic purposes but for an event, a film shoot or something similar, you will need a special use permit.
Volltext	Roads are used for the purpose of movement and transport. This is known as public use. If you want to use a road outside of public use, you need a special use permit. This can be, for example, for: a celebration a rally a cycling race a sporting event Film and television recordings Who you apply to for the special use permit depends on where the special use is to take place. For country roads, the regional road construction authority is responsible, and for motorways, the relevant motorway company is responsible. If you have already obtained an exemption and permission for further use, you do not need a special use permit. The permit is granted to you temporarily or revocably and may be subject to conditions and requirements.
Erforderliche Unterlagen	Depending on the matter, different documents are required. The responsible authority can inform you accordingly.
Voraussetzungen	In order for the special use to be approved, you must ensure that: public services are only briefly affected temporarily constructed facilities be approved separately are safe You are liable for any damage caused
Kosten	The costs vary depending on the individual case. The responsible authority can inform you accordingly.
Verfahrensablauf	You submit your complete application to the responsible authority. The responsible authority will check your information and, if necessary, request any missing documents or information from you. The

	responsible authority will inform you of its decision in writing.
Bearbeitungsdauer	A specific processing time cannot be given and varies depending on the type of special use.
