Teaser	An additional guardian is appointed if the parents or guardian are actually or legally prevented from taking care of certain matters.
Volltext	Supplementary guardianship is the judicial transfer of part of the parental care for a minor to another person, namely the so-called supplementary guardian. The rights and duties of the supplementary guardian are limited to these parts of the personal care or the care of the property when appointed. The guardian is appointed by the family court at the respective local court.
Erforderliche Unterlagen	No documents are required.
Voraussetzungen	A guardianship is not a service that is actually applied for. It is established when the local court becomes aware that a guardianship is necessary.
	 This may be the case, among other things, if parents with custody point out that they are overwhelmed by a situation, an authority indicates that guardianship appears necessary, it is determined in court proceedings that

	guardianship must be established.
	A carer is appointed if the child is under parental care or guardianship, but the parents or guardian are or are prevented from taking care of certain matters for factual or legal reasons.
Kosten	The decision on supplementary guardianship will determine who will bear the costs of the proceedings and the guardianship. The decision depends on the reason for and content of the supplementary guardianship. If the parties consider legal representation to be necessary, the costs of this representation must of course be borne. If necessary, it is possible to apply for legal aid.
Verfahrensablauf	 The local court will appoint a suitable person as additional guardian by order if it becomes known that guardianship is necessary. The local court decides who will be given responsibility for the guardianship. The certificate of appointment defines the area of responsibility of the supplementary guardian.
Bearbeitungsdauer	The appointment of an additional guardian will take place promptly.
Frist	There are no deadlines to be observed.
