| Teaser | If you want to have an entry made in the land register, in most cases you will need the certified consent of the person who will suffer a disadvantage as a result of the entry. |
| Volltext | The land register is a public register in which all important information about properties and their rights are recorded. It provides information about who owns a property, what encumbrances are on it (for example, mortgages or land charges) and whether there are any special rights or restrictions. It is kept at the land registry office of the local court. If you want to have an entry made in the land register, you usually need a certified consent from the person who will be disadvantaged by the entry. If, for example, a land charge is to be registered, the owner of the property on which the land charge is to be placed is affected. You need his certified consent. The registration authorization must be certified by a notary. To do this, contact a notary directly. They will not only carry out the certification, but will also advise you on land registry matters and can submit the necessary applications for you. |

| Kosten | The costs for certification and notarization are governed by the Court and Notary Fees Act (GNotKG) For the specific costs, please contact a notary of your choice. |
| Verfahrensablauf | The land registry office does not certify documents. Please contact a notary of your choice for this. Find a notary using the nationwide notary search. Make an appointment. Ask the notary for advice on the desired registration. The notary certifies the permit and usually also applies for registration at the land registry office on your behalf. |
| Bearbeitungsdauer | The processing time depends on the respective notary office. |
