Volltext	If you want to exhibit animals or allow someone else to exhibit your animals, you need a permit.
Erforderliche Unterlagen	<p>Application for permission under the Animal Welfare Act</p> <p>Submission of a certificate of good conduct for submission to an authority, not older than 6 months</p> <p>Information from the Central Trade Register, not older than 6 months</p> <p>Please provide the following information in your application: planned activities</p> <p>Place of business (business address)</p> <p>Owner of the business (name, address, date and place of birth)</p> <p>Information about the person responsible for the activities, if this person is not the same as the respective business owner (name, address, date and place of birth)</p> <p>Species and numbers of animals to be kept</p> <p>Please submit the following documents with your application: Evidence of the reliability of the business owner</p> <p>Evidence of the expertise and reliability of the responsible person</p> <p>Site plan of the buildings and areas showing the use as well as rental or lease agreement or declaration of ownership</p>
Voraussetzungen	<p>There are no animal welfare concerns. The responsible persons and their deputies have the necessary expertise</p> <p>You or the business owner have the necessary personal and financial reliability. The available premises and facilities are suitable for keeping the animals in a species-appropriate manner.</p> <p>You may only exhibit the animals at different locations</p>

	if this is not prohibited by law.
Kosten	Fees apply. The amount depends on the processing effort.
Verfahrensablauf	You apply for permission under the Animal Welfare Act with the necessary documents to the responsible authority. The responsible authority will review your documents and, if necessary, request additional documents or information from you. The responsible authority will examine your application. You will receive a notification.
Bearbeitungsdauer	Processing usually takes 4 to a maximum of 6 months if all required documents and evidence are available.
Frist	You need permission before you can exhibit the animals.

Hinweise	The permit applies only to the species and maximum number of animals with which the activity is to be carried out, as well as to the premises and facilities specified in the application. A permit issued based on incorrect information is invalid and can be revoked at any time. The responsible authority generally does not check whether building regulations, emissions control regulations, commercial regulations, or species protection regulations are met. For example, animal shelters and kennels are not permitted in residential areas under building regulations. The department therefore recommends checking with the relevant authorities regarding the requirements in other legal areas before submitting an application.
