Volltext	If you operate a medium-sized combustion plant, gas turbine or combustion engine plant, you must, under certain conditions, determine pollutant emissions through continuous measurements. You must prepare a measurement report for each calendar year on the results of the measurements and send it to the responsible authority within the deadline.

Voraussetzungen	You are the operator of a medium-sized combustion, gas turbine or combustion engine plant. You have put your system into operation.

Kosten	Gebühr: Es fallen keine Kosten an
Verfahrensablauf	They evaluate the continuous measurements of each calendar year. You create a measurement report based on the results. You send the measurement report to the responsible authority on time.
Bearbeitungsdauer	The processing time depends on the individual case.
Frist	Submit the measurement report for each calendar year to the responsible authority by March 31 of the following year at the latest. Keep the measurement report and the measuring instrument records for at least 6 years after the end of the respective reporting period.
