Volltext	<p>Upon written request, the expert committee for real estate values prepares, among other things, individual expert opinions on the market value of:</p> <ul style="list-style-type: none"> <li>• undeveloped land</li> <li>• developed land</li> <li>• condominiums</li> <li>• heritable building rights and</li> <li>• on the value of rights to real property (e.g., portions of old property or residential rights).</li> </ul> <p>The basis for the valuation is the collection of purchase prices of the expert committee , in which all purchase contracts for real estate in Bremen are collected and evaluated.</p>

Voraussetzungen	<p>Eligible to apply are</p> <ul style="list-style-type: none"> <li>• Owners</li> <li>• co-owners</li> <li>• person entitled to inherit by presenting the certificate of inheritance</li> </ul>
Kosten	<p>As a rule, the following fee rate applies (plus value added tax): for market values up to 500,000 : 4.5 of thousand of the fair value plus 900 for market values from 500,000 to 1,000,000 : 1.1 of thousand of the fair value plus 2600 for market values above 1,000,000 : 0.8 of thousand of the market value plus 2900 However, there are some exceptions! Inspection of the valuation object by the appraisal committee (3 independent experts) with subsequent consultation of the market value</li> </ol>
