Teaser	If a passport - even in the "express procedure" (within 3-4 days) - can no longer be issued in time before the start of your trip, you can obtain a temporary passport. The current legal requirements for passport photos can be found under "Further information" - "Notes on digital passport photos".
Volltext	The temporary passport is generally issued only in connection with the application for a "normal" passport.
Erforderliche Unterlagen	• Proof of identity e.g. old or invalid identity card, valid passport or birth certificate for young children who do not yet have a passport or identity card. • 1 QR code to retrieve a digital passport photo or take your photo directly at the BürgerServiceCenter Please arrive 15 minutes before your appointment. Under "Further information" - "Notes on digital passport photos" you will find further important information. • Declaration of consent by the person with custody as well as their identity documents (also possible as copies) and, if applicable, proof of custody • Proof of custody with a single guardian
Voraussetzungen	Since 12.12.2005, this must be machine-readable. As a rule, a temporary ID card is only issued if a new passport (ePassport) is applied for at the same time or has already been applied for. In very exceptional cases (for example, if a person who is older than life can

	prove that the passport is only needed for a one-time trip abroad), only a temporary passport can be issued. If the applicant is under 18 years of age or if a guardian has been appointed for him or her (for the purpose of determining the child's place of residence), all legal guardians must consent to the issuance of the temporary passport, but in any case the custodial parent with whom the child has his or her habitual residence legally (with the consent of the other parent or on the basis of a court decision). Important: This is a service under municipal jurisdiction. Therefore, you can only go to a service that is located in your place of residence.
Kosten	Gebühr: 6€ Photo costs (if no photo is transmitted by the photographer via a QR code brought along). depending on the type of document
