Hinweise	• The real estate cadastre must meet the requirements of legal transactions, administration and business as a basic information system. • The real estate cadastre must serve as an official register in the sense of the land register regulations. • The real estate cadastre consists of the cadastral survey work (Risse), the cadastral maps (Liegenschaftskarten) and the cadastral book work (Liegenschaftsbuch) and is jointly maintained in the Official Real Estate Cadastre Information System (ALKIS).
