Teaser	If you need information on standard land values, for example in advance of a property purchase, building project or for property tax purposes, you can view the standard land values online or obtain written information and extracts.
Volltext	The standard land value indicates how much a square meter of land in a certain area is worth. For this purpose, the average value of the land is determined for several properties within a specific area (standard land value zone). The characteristics of the land, such as the type and extent of usability, are the same and the general value ratios are the same. The standard land values are determined by the expert committees for land values.

Kosten	There are no costs for independent access to the online service.
Verfahrensablauf	You can request access via the online service, in paper form or by telephone.
