Volltext	The 3rd ordinance amending the Driving License Ordinance provides for the international code number 96. The driving license is issued for vehicle combinations consisting of a motor vehicle of class B and a trailer with a maximum permissible mass of more than 750 kg, provided that the maximum permissible mass of the vehicle combination exceeds 3,500 kg but does not exceed 4,250 kg. Persons who are in possession of the class B and have the minimum age of 17 years can drive the class B96 by participating in a driver training course according to appendix 7a of the driver's license ordinance. The authorization is documented by the entry of class B with the key number 96 in the driver's license.
