Teaser	Do you wear glasses or contact lenses? Find out more about the restrictions/requirements for your driver's license here.
Volltext	If you no longer need glasses or contact lenses when driving after an eye operation or due to natural changes to your eyes, you can have this restriction removed from your driver's license. Of course, this is only possible if your driving license states that you must wear glasses or contact lenses when driving. Otherwise you could get into trouble at a traffic stop. A medical certificate alone is not sufficient. The same applies to other health changes resulting from operations. These can lead to the conditions or restrictions on your driving license having to be changed. In such cases, the driving license authority will check whether the conditions or restrictions need to be changed or removed. You will normally have to submit a medical certificate for this. In such cases, please contact the driving license authority.
