It serves to ensure legal certainty in commercial transactions by providing complete and reliable evidence of the factual and legal circumstances whose disclosure is of particular interest to the general public. Two sections are maintained:</p> <ul style="list-style-type: none"> <li>• Department A: For sole traders and partnerships (e.K., OHG, KG).</li> <li>• Department B: For corporations (GmbH, AG)</li> </ul> <p>The commercial register enjoys public faith. This means that bona fide legal transactions are protected to a limited extent in their trust in the correctness of the entries and announcements.</p> <p>The content of the entry is published ex officio in the electronic Federal Gazette.
