Verfahrensablauf	You must submit a notarized application for conversion to the competent local court. The court examines the application and also involves the locally competent youth welfare office and the central adoption office of the state youth welfare office during

In addition, if he or she is not yet 18 years old at the time of the application, he or she will receive German citizenship if you or your husband or wife are German citizens.</p>
