Pharmacists or persons with a certificate of a university degree in pharmacy, chemistry, biology, human or veterinary medicine.</li> <li>2. Pharmacist assistants, as well as persons who have completed training as technical assistants in pharmacy, chemistry, biology, human or veterinary medicine.</li> <li>3. Pharmaceutical assistants.</li> </ol> <p>Pursuant to Section 75 (3) AMG, the competent authority may recognize as sufficient a passed examination or completed training that is at least equivalent to one of the training courses of the above-mentioned persons.</p> <p>Please note: The examination and certification of expertise according to § 75 AMG is subject to a fee.</p> |
