Volltext	External learning sites in the field of environmental education and global learning with existing cooperation agreements can apply to the Senator for Children and Education for a grant. To promote their work, the external learning sites / educational partners:inside (according to a cooperation agreement) can submit applications for grants. These applications must be re-submitted annually. After completion of the measure, a final report on the use of the funds is submitted to the Senator for Children and Education. This report is checked for content and expertise and archived in the Financial Management Department.

Voraussetzungen	Eligibility to apply must be present.

Verfahrensablauf	• The applicant submits an application for a grant to the Senator for Children and Education, Department 20 - Quality Development and Standard Assurance. • The State Coordinator reviews the content of the application and, if it is positive, submits it to the Financial Management Unit as a note for further processing. • The Financial Management Unit reviews the application from a financial perspective and provides feedback to the State Coordinator. • The financial management writes the notice of approval and instructs the money to be disbursed.
