Volltext	<p>The aim of the counseling service is to support trainees with difficulties of any kind. It does not matter whether the difficulties arise in the company, at vocational school or privately. The aim is to prevent trainees from dropping out at an early stage. A change to alternative training can also be supported in the long term.</p> <p>This voluntary service is aimed at trainees whose training relationship is at risk due to problems of various kinds. The aim is to mediate between the parties in a solution-oriented manner and to prevent trainees from dropping out of training or, in certain cases, to provide long-term support in the process of ending the training relationship until a suitable follow-up perspective has been created.</p>
