Teaser	If you would like to vote in an election by postal ballot, you can apply for a polling card/postal ballot.
Volltext	Eligible voters can apply for a polling card / postal voting documents. The documents are generally sent by post. It is possible to collect them in person.
Erforderliche Unterlagen	No documents are required for the application. An application can also be submitted informally. However, the following mandatory information is required: Surname, first names, date of birth, registration address. If the polling card/postal voting documents are collected in person, a valid photo ID must be presented.
Voraussetzungen	The prerequisite for applying for a polling card or postal voting documents is that the applicant is eligible to vote.
Kosten	There are postage costs if the application is sent to the electoral office by post. There are no other costs.
Verfahrensablauf	Anyone entitled to vote can apply for a polling card/postal voting documents. The application can be made in person, in writing, by email, by fax or via an online form.
Bearbeitungsdauer	1 to 3 working days. Please note the postal delivery times for the delivery of the polling card / postal voting documents.
Frist	In each case from the 41st day before an election to the 2nd day before an election, 3 pm. The application is

	generally possible until 3 p.m. on the 2nd day before the election. The possibility of applying via the online form therefore ends on the fifth day before the election.
