<b>Teaser</b>	The procedure pilots "guide" children and young people (and their relatives) through the integration assistance benefit system. They provide support with applications and the realization of entitlements and rights.
<b>Volltext</b>	<p>The procedural pilots have the task of informing and advising young people with an (impending) disability and their legal guardians and accompanying them through the application process with various authorities.</p> <p>The procedure pilots also support the youth welfare offices in preparing for "inclusive child and youth welfare".</p> <p>From January 1, 2028, all assistance for young people with and without disabilities is to be brought together under the "umbrella of youth welfare".</p>

<b>Voraussetzungen</b>	<p>Young people under the age of 27 who are or may be entitled to integration assistance due to an (impending) disability are entitled to the support of the procedural pilots.</p> <p>The counseling requirement is therefore not only aimed at children and young people, i.e. minors, but also at the group of "young adults".</p> <p>The service is also aimed at the legal representatives of young people.</p> <p>It should be emphasized that the right to support and guidance does not require that an existing or impending disability has already been diagnosed.</p>
