Volltext	It is not permitted to bury pets on your own property in the state of Bremen. You can purchase the right to use a burial site and have your pet buried at the pet cemetery. If you have already acquired the right to use a burial plot, you can have this extended.

Voraussetzungen	It must be a pet weighing up to 100 kilograms. If the right of use is extended, the burial site must be an elective burial site.

- Enter the grave number
- Name and address of the beneficiary
- Fill in the analogous application form. You can obtain the application form from the Horticultural Office or directly from the pet cemetery

	Once the application has been successfully checked and payment has been received, the right to use a grave will be granted or extended.
Bearbeitungsdauer	The processing time depends on the workload.
Frist	The minimum resting times depend on the size of the animal. Pet urns and small animals weighing up to 1 kg, grave size 40 x 30 cm Medium-sized animals from 1 to 5 kg in weight, grave size 80 x 60 cm Large animals from 5 to 70 kg, grave size 80 x 120 cm Oversized animals weighing 70 kg or more, grave size over 80 x 120 cm
