Volltext	The establishment of supplementary schools must be notified before teaching begins. The notification must contain precise information about the type of school, the structure of the lessons and the school's objective.
Erforderliche Unterlagen	• Evidence Proof of the personal reliability of the provider, the director and the teaching staff (extended police clearance certificate). • Further information Display with precise details of the type of school, the start of lessons, the structure of the lessons and the school's objective.
Voraussetzungen	The application must be submitted to the Senator for Children and Education. The application can be submitted informally. In accordance with § 4 of the Private Schools Act, private schools subject to approval or notification under this Act must have a name that identifies them as a private school. Incorrect or misleading names may not be used. The establishment of supplementary schools must be notified to the Senator for Children and Education before teaching commences. The notification must contain precise information about the start of teaching, the type of school, the structure of teaching in accordance with § 14 Para. 1 Brem. Private Schools Act and with reference to § 14 para. 3 Brem. Private Schools Act and the educational objective.
Kosten	According to the cost regulation of the education administration, there is no cost rate for the mere notification of a supplementary school.

Modul	Sachverhalt
Verfahrensablauf	The Senator for Children and Education checks that the application documents are complete and correct. The notification as a supplementary school is confirmed by the Senator for Children and Education if all requirements are met.
Bearbeitungsdauer	The Senator for Children and Education will make a decision within three months after all the necessary documents and evidence have been submitted.
Frist	There are no deadlines for the application process. However, the school may not commence operations until the state confirmation of the application has been received.
