If the responsible state authority does not make the desired state-wide spatial development plan available on the Internet, you have the right to view it at the state authority. The state-wide spatial development plan generally consists of:</p> <ul style="list-style-type: none"> <li>• Indication of the legal basis on which the spatial development plan is based,</li> <li>• the definition of objectives and principles of spatial planning and</li> <li>• justification and explanations of the objectives and principles of spatial planning.</li> </ul> |
